## NOTICE FROM THE TRAVEL OFFICE

The following steps will allow the designee who encumbers the funds to access the page for the traveler's attachment.

- 1. Go to Banner Web
- 2. Finance
- 3. View Document
- 4. Choose Type-Select Encumbrance
- 5. Document Number-Type in the encumbrance number
- 6. Select Approval History (It should only show awaiting approval from Purchasing)
- 7. Save as a PDF or print screen
- 8. Attach Encumbrance sheet in Concur
