## Manuscripts In Progress

- I am currently doing research in the area of privacy particularly in the context of cloud using large data sets
- Currently analyzing data obtained why consulting at a telecommunication company on compliance with CMM Level 3 objectives after a merger.
- Near completion is a paper that uses the four-typed privacy definitions developed by myself and Solove's taxonomy of privacy harms. Using both of these, the security training course and the Information Security Manual of the VA medical center are examined. A frame work of medical information compliance and how to write medical information compliance policy will be proposed as a way to confront ad hoc policy creations and applications that are tech driven.
- Near completion is a paper that uses the four-typed privacy definitions developed by myself and Solove's taxonomy of privacy harms. This paper applies a framework for developing meta data in the DBMS to ensure PHI privacy.
- I am currently working with a hospital risk management team to develop a tool in which compliance with HIPAA can be assessed on existing systems.
- Paper is near completion to submit to conference on how physical beauty impact career choice and path in the hotel and restaurant business and the legal implications faced by employers
- Two papers are near completion for submission to journal. One paper deals with student conception of their role in finding a job while engaged in university study. The second paper deals with how students look for job and internships and how they go about finding them
- Near completion of a paper on privacy practices used in the library setting asking the question whether current federal case law provides sufficient protection to library patron privacy expectations
- I am also completing a project where IT personnel in a hospital setting are being trained in the use of a privacy tool. This tool has been constructed by myself and proposed to help set access to PHI as well as test information security in a PACS system. Once trained, the subjects are assessed on how the tool assists them in doing daily tasks as well as on how the tool improves overall security and access. The results from each will be subjects for upcoming papers.
- In response to the strictures of the GRAD Act, I researched and prepared a short paper regarding the challenges and problems facing graduation of students within 4 years of enrollment in a university or college. This paper has been provided to the Dean of the College of Business who published it to the faculty of the College of Business. It has also been provided to the President of the Faculty Senate and various members of the Faculty Senate of Grambling State University. Currently this document serves as the basis of a study being conducted by the Faculty Senate Committee for Curriculum and Academic Affairs
- To confront the problem of retention of students, I have been conducting a study of students to understand (1) How to motivate them to want to learn (2) Promote actual learning. Using the concept of elucidation, for the past (2) years studies have conducted of students seeking what goals they have and

then tailoring the teaching to demonstrate to the student the usefulness of the material. Data analysis is in its final phase. Currently research is being done on what journals and conferences to target the articles. It is anticipated one paper will be submitted to a conference and one to a journal in 2015

- To confront the problem of placing students in gainful employment after their matriculation from the university I have been conducting a study of students to understand how students choose careers, when do they choose their career and how they use college to achieve their career goals. For the past two years data has been gathered on these issues. Currently two papers are near completion to be submitted to conferences to be held in the Spring of 2015. Currently I am in the process of targeting journals to submit the papers after they are presented at conference with the submission to journal anticipated Spring 2015
- Currently I am collecting data on the issue whether people in virtual places view privacy or have privacy interests the same or similar than people in non virtual places. A paper was accepted at IACIS Conference, Las Vegas, NV held October 6- 9, 2010, for the paper Virtual Privacy: Real or Virtual. Work continues on the paper
